NOTICE OF RACE**

Amendment June 4, 2013 regarding guest boats racing with J-70 class

The Newport Yacht Club (NYC) Regatta Committee as ORGANIZING AUTHORITY invites J/70 class boats visiting Newport to join the 2013 One Design Summer Series to race on a singular night basis.

Sailing Instructions and Notice of Race available on the NYC web site, <http://www.newportyachtclub.org/> will govern all racing with the following exceptions:

3. ELIGIBILITY AND ENTRY

- 3.1 All J/70 One-Design class boats visiting Newport Harbor are invited to race in the One-Design series. Racing is open to all eligible boats that have registered. To compete and be scored, a boat must be properly registered with the Newport Yacht Club Regatta Committee as required by paragraph 4 of this NOR.

4. FEES AND REGISTRATION

- 4.1 To be properly registered the following documents must be submitted to the Newport Yacht Club Regatta Committee, 110 Long Wharf, Newport, RI 02840, at least 4 hours prior to the race in which the competitor will be scored:
- 4.1.1 Completed registration form.
 - 4.1.2 A check made payable to the Newport Yacht Club for the appropriate entry fee of \$20. US Sailing members receive a 10% discount.
 - 4.1.3 A RELEASE, WAIVER AND COVENANT NOT TO SUE signed by the yacht owner and/or skipper.
 - 4.1.4 Evidence of liability insurance for each boat entered.
- 4.2 The OA reserves the right to accept or deny entries submitted beyond stated deadlines.

10. SCORING

- 10.1 When a guest boat or boats join an evening of racing, a listing of all boats in the order of finish will be posted on the bulletin board. Normal scoring procedures will be followed for all boats registered for the entire series.
